Application Rates & Recommendations:

Vegetables: Apply 1 quart per acre before flowering and 1 pint every 14-21 days

Turfgrass: Apply 1 ounce per 1000 sqft every 30-45 days

Ornamentals: Apply 1 pint per 100 gallons of water to runoff. Apply 2-3 teaspoons per 1 gallon of water

Soil Applications: Apply 2-4 quarts per acre

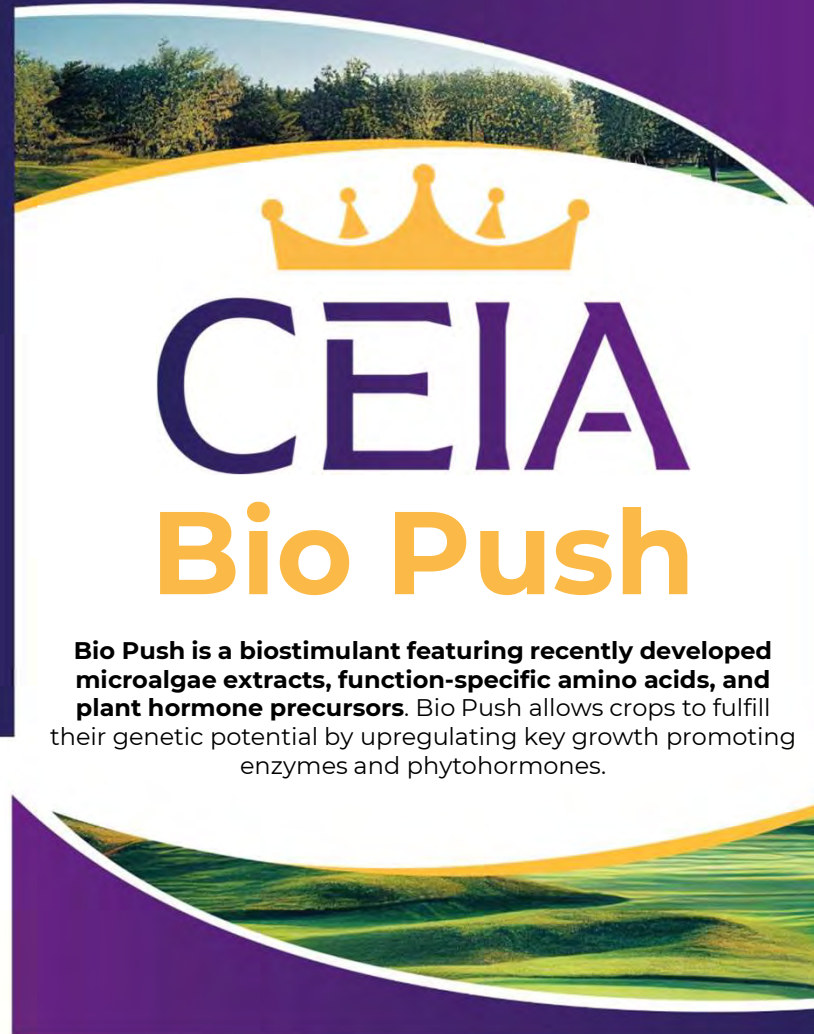
Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility of unknown mixes. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions.
