Fertigation: Apply 1-6 quarts per acre as needed

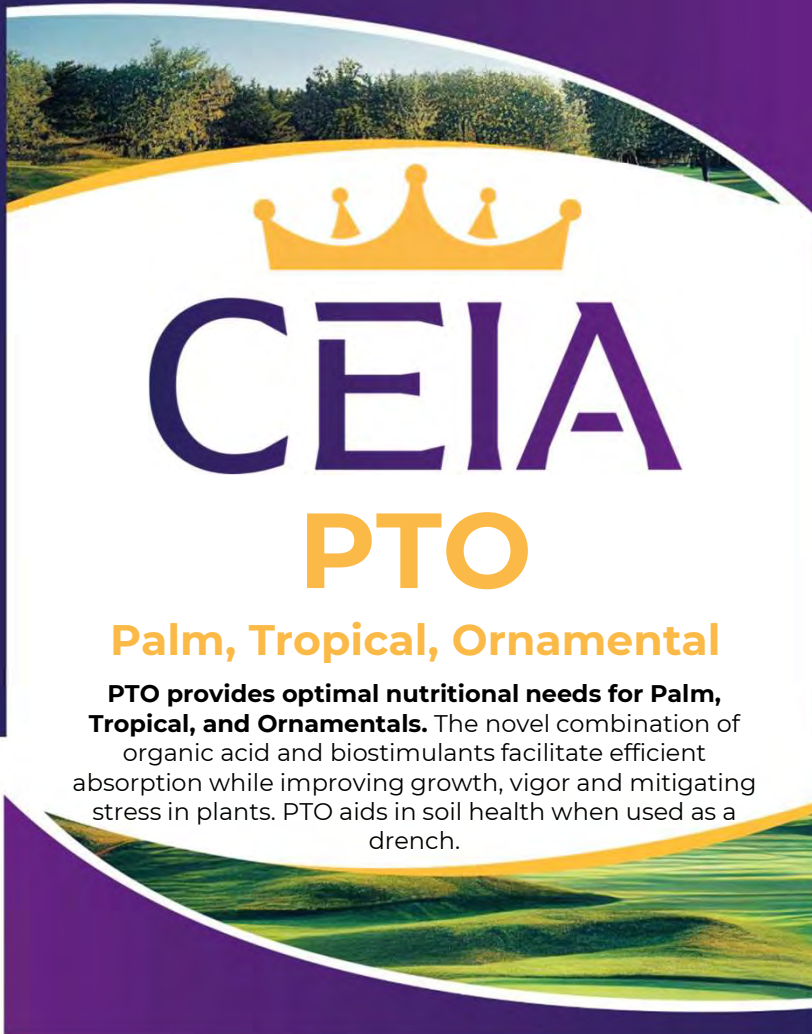
