APPLICATION RATES:

Turfgrasses: Apply 2-8 oz per 1000 sqft biweekly or as needed

Tees & Greens: Apply 5-8 oz per 1000 sqft as needed

Ornamentals: Apply 2-4 quarts per 100 gallons of water and spray to runoff

Commercial Sod: Apply 1 to 2 gallons per acre
