APPLICATION RATES:

Shrubs & Ornamentals: apply 1-8 quarts per 100 gallons and spray to runoff

Potted Plants: use 1 tablespoon per gallon of water

Lawn & Turf: use 2-12 fl oz per 1000 sqft in enough water for thorough coverage biweekly or as needed

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility of unknown mixes. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions
