Application Rates & Recommendations:

Warm & Cool Season Turf: Apply 3-6 oz per 1000 sqft for maintenance. Apply 8-12 oz per 1000 sqft for severe deficiency. Apply biweekly or as needed.
Ornamentals: Apply 1-2 quarts per 100 gallons of water and spray to runoff as needed.
Commercial Sod: Apply 1-3 gallons per acre to green up turf as needed or before harvest.
